




## Corner Shot Around the World

As the assault element commander for 4th platoon during this deployment, I was directly responsible for the training and employment of the CornerShot. During our deployment we successfully cleared several hundred buildings using the CornerShot and sustained zero casualties. The CornerShot allowed us to complete some of the most dangerous aspects of close quarters battle without endangering my Marines. The degree of stand off that the CornerShot allowed us to maintain from enemy personnel allowed us increased time to decide and act on a course of action. During our operations we were to disarm one insurgent who we otherwise would have shot had we not had the CornerShot. Because of his capture, we were able to gather intelligence leading to several other insurgents being detained. It is my opinion that the CornerShot is an excellent piece of equipment, which will potentially save many lives. I have also sent you an after action report detailing my views on the CornerShot and I hope you will find them useful in your product development.

Dear Mr. Rami Shaul,

I just wanted to send you a letter of appreciation for your Cornershot weapon system. Last year we purchased Cornershot weapon systems for our Swat Team and we are highly recommending it to all other agencies in our area.

Over the last year we have deployed it in at least 100 high risk entries and several barricades.

One thing I have found out working Swat for the last 20 years is equipment is great, but tactics save lives. Let me explain. Over the years we have used cutting techniques (Pie) to search rooms and it works great, but you still leave yourself open at some point. Then the search mirrors came into play, but holding mirrors and flashlights and weapons just makes the searching difficult in CQB areas and you still have a delay in the use of deadly force, if needed.

The next generation of gear we used was search cameras poles and they worked well, but the tactics still made the CQB cumbersome.

Since we purchased the Cornershot last year, we have found that the system works great in the Swat operation areas of CQB. The system lets the operator have a weapon light & laser, a camera and a firearm all in one, and in a single operator's hands, so there is no time lag between seeing and using.

The weapon system has given the operator the tools to search as he moves and we find it works great in searches of attics and craw spaces, and in tight spaces like under beds and closets and stairs.

Just last week we had a man that barricaded himself in a house after he beat is girlfriend with a high power rifle and threaten to kill anyone that would come after him.

After 1 hour of trying to negotiate with him, we were ordered to go in and take him into custody.

After searching the entire 3 story house we made our way to the basement cellar area, the last place to search, and we found him in a small area under the stairs.

Using the Cornershot I was able to search around the corner, between a washer and dryer, and spotted the suspect hiding.

The great thing with the Cornershot system is that even if he would have gotten a shot off at me, I was behind a brick wall and had great cover, but yet, I had the shot if needed.

Good tactics and good equipment makes safe missions.

Thank for your products, and just to let you know, we are now going to order our second Cornershot weapon system.
